## Hope Gas Opens New HQ Office in Morgantown, WV

On June 19, a ribbon-cutting ceremony was held to celebrate the grand opening of the new Hope Gas Corporate Headquarters in Morgantown, West Virginia.

The new, 35,000-square-foot facility is located in the West Virginia University Innovation Corporation's Chestnut Ridge Road facility and will house all the logistical operations for the state utility.

Last year, Hope Gas was sold by original parent company Dominion Energy to Hearthstone, a holding company of Ullico, the only laborowned insurance and investment company in the United States.

At the time, Hope Gas had approximately 300 employees, 111,000 West Virginia customers with 3,200 miles of gas distribution pipelines, and more than 2,000 miles of gathering pipelines.

Shortly thereafter, Hope Gas purchased an additional 900 miles of gathering pipelines from Equitrans Midstream Corporation.

Then, in January of this year, Hope Gas announced plans for further expansion, through the purchase of Peoples Gas West Virginia. The pending transaction is valued at \$37 million and will increase Hope Gas's customer base to more than 125,000 in their network.

## Union Contractor Awarded High Voltage Work at Form Energy Battery Plant

Last month, union contractor Bruce & Merrilees Electric Company announced it would be partnering with Form Energy to work on their new battery factory project in Weirton, West Virginia.

Sources say the contractor was awarded \$200 million of high voltage work.

Form Energy is currently building the battery plant on 55 acres at the site of the old Weirton Steel property.

The Form Energy project began in the wake of the passage of the Inflation Reduction Act (IRA), a piece of federal legislation which provided significant tax incentives for developers to build new and emerging energy-related projects.

In addition, the company was courted by the West Virginia Department of Economic Development (WVDED) to locate their battery factory in West Virginia.

According to a January 2023 Memorandum of Understanding (MOU) between Form Energy and the WVDED, the state of West Virginia purchased the 55 acres of land and will be funding any "necessary infrastructure advancements" that may be needed as a part of the preconstruction.

The MOU also outlines how the project will be completed in three

## **Racing & Gaming Facility Construction Underway at Ashland, Kentucky Site**

Earlier this year, members of the Tri-State Building and Construction

Council Trades began construction on a new racing and gaming facility in Ashland, Kentucky.

Tri-State has partnered with Revolutionary Racing Kentucky to build Sandy's Racing and Gaming, a \$75 million state-of-the-art quarter horse racetrack, gaming club, and equestrian center.

The project is being built on the

abandoned Sears site at the old Kyova Mall in Boyd County, Kentucky.

The gaming club at Sandy's Racing and Gaming is set to open later

> this year, while construction on the racetrack is expected to completed Spring 2025.

> Over the course of the last three months, hundreds of Tri-State workers have been hard at work to build the facility, and progress is on schedule.

> "We are incredibly proud of our partnership

and the 50 local unions they represent," said Larry Lucas, Chairman of Revolutionary Racing Kentucky. "The trades have been outstanding to work with, thanks to their commitment to quality and schedule."

Last year, Revolutionary Racing Kentucky received the ninth and final horse racing facility license from the State of Kentucky, which made the project possible.

When the racetrack opens in Spring 2025, it will feature a 600-yard sprint racetrack and equestrian center, built adjacent to the gaming club on the 177-acre property.

To date, the project has created more than 200 well-paying jobs for workers, and the facility is expected to generate more than \$1 million in

"We truly appreciate the commitment shown by the owner Larry Lucas and the entire Revolutionary Racing Team in partnering with the local Building Trades Unions," said John Holbrook, Business Manager for the Tri-State Building and Construction Trades Council.

"We know Revolutionary Racing Kentucky will be happy with the result, and we believe this project will be another example of the great work that can be produced by our highly skilled, safe and drug-free workforce." ■

The sale is expected to close later this year.

Currently, Hope Gas has 400 employees, and according to representatives from Hope Gas, more plans for expansion are currently in the works.

If those plans stay on schedule, the company could serve more than 200,000 customers in 35 West Virginia counties over the next five years.

During the ceremony, members

of labor were also on hand to take part in cutting the ribbon on the new Hope Gas headquarters.

"We are excited about the expansion of Hope Gas in West Virginia," said Jessie King, Business Manager of the West Virginia Appalachian Laborers' District Council. "All of this means one thing: good-paying jobs with health and pension benefits. Ultimately, this will be a great thing for our people and the entire state."

phases, setting production benchmarks for Form Energy, which then triggers the next phase.

Phase 1 of the project includes the construction of a 100,000-squarefoot facility to house the battery manufacturing equipment.

Once Form Energy sells 5 MW of energy contracts and hires 65 employees, Phase 2 will begin.

Phase 2 includes an expansion of the facility up to 350,000 square feet and requires Form to sell an additional 45 MW of energy contracts and hire 178 full-time employees.

Finally, Phase 3 of the project will be an expansion of the facility up to 400,000 square feet and requires Form to sell 500MW of energy.

As a part of the deal, West Virginia will own the buildings and land, with Form leasing it back.

The property will transfer to Form Energy after five years if the company meets all of the criteria and benchmarks laid out in the MOU.

## **WVSBT Begins Filming Recruitment Ad for Construction Apprenticeship Programs**

Earlier this month, the West Virginia State Building and Construc-

tion Trades and ACT began work on an upcoming advertisement, featuring apprentices, to recruit the generation construction craftworkers.

The advertisement is part of a larger campaign to rebrand the trades and increase the number of applicants construction for craft apprenticeship programs, in response to the increase in work due

to the Bipartisan Infrastructure Law and the Inflation Reduction Act.

In addition to the commercial,

the larger campaign also includes the development of a new website, which

> will be used to provide information for contractors as well as those interested in starting an apprenticeship program.

> website The will serve as a landing page, to which other print and media advertisements will direct interested applicants.

> "There never been a better time to start a career in the trades," said John

Epperly, Secretary-Treasurer for the West Virginia State Building and Construction Trades Council. "It's

important for us to get the word out about our programs, and increase our numbers, to take advantage of this incredible opportunity.

The opportunity Epperly is speaking about is the influx of federal infrastructure dollars to our state due to the Bipartisan Infrastructure Law and the Inflation Reduction Act.

Over the course of the next de-

cade over \$6 billion dollars has been allocated to West Virginia for public infrastructure projects from the Bipartisan Infrastructure Law alone.

In addition to these funds, the Inflation Reduction Act will provide billions of dollars in tax incentives to developers and contractors who pay Davis Bacon Wages and use apprentices on a jobsite.
