WV Building Trades Hold Legislative Conference

On January 17, the West Virginia Building and Construction Trades Council (WVBCT) held their 2024 Legislative Conference at the Four Points in Charleston, West Virginia.

The conference is held each year and brings members from across the state to hear from WVBCT leaders about the organization's position on numerous legislative issues.

In addition, members are able to hear from lawmakers and construction industry officials about the potential issues facing the trades during the ongoing legislative session at the Capitol.

This year, trades leaders warned of the proposal to cut unemployment benefits and bills to conceal public construction payroll documents. However, WVBCT leaders also said the session has potential for positive legislation as well.

"Obviously we are working hard with our friends at the Capitol to continue fighting the terrible bills that would cut unemployment benefits," said George Capel, Government Relations Director for the West Virginia Building and Construction

"However, we are also very optimistic about two proposals. [One

bill] would help us promote apprenticeship in public schools and anoth-

Trades Sign Agreement to Build Natural Gas Power Plant in Doddridge County, WV

On January 29th, the West Virginia Building and Construction Trades Council and the North Central Building and Construction Trades Council signed an agreement with CPV Shay, LLC to build a natural gas-fueled combined cycle power plant in Doddridge County, West Virginia.

CPV Shay, a subsidiary of Competitive Power Ventures, is calling the project the CPV Shay Energy Center and claims the deal amounts to a \$3 billion investment by the company.

According to a release from CPV Shay, the project will be built on 54 acres of a 230-acre plot of land in

Blandville, WV and the facility will have a generating capacity of approximately 2,060 MW.

In terms of the construction, CPV Shay representatives say the project will create roughly 2,000 jobs during peak construction and 1,200 jobs annually throughout the three-year

construction timeline.

The MOU outlines the project, saying the project "may or may not include an integrated carbon capture facility" as well.

"We look forward to partnering with CPV Shay to build this project,"

Final Structural Beam Raised at Ongoing Form Energy Project in Weirton, WV

Earlier this month, Form Energy officials held a ceremony to commemorate the final beam being placed at the iron-air battery manufacturing facility project in Weirton, West Virginia.

Company officials, members of the construction crew and other guests gathered at the site of the project for the "topping out" ceremony, which is a major milestone in the development of the new facility.

"It has been such a journey to get here," said Ted Wiley, President and Chief Operating Officer for Form Energy. "We looked all over the country for a place to build Form's first factory. I couldn't be more happy and feel more fortunate that we decided to pick Weirton as the place for Form's new home."

Form Energy originally held a ceremonial groundbreaking for

Form Factory One on May 26, 2023, with the first steel raised on the site July 21.

Since that time, more than 700 piles of earth have been brought in to help level off the site, with more than 3,000 tons of steel erected and more than 300,000 square feet of concrete poured, along with a roof and exterior walls installed.

According to company officials, equipment will be moving on site throughout the spring and early summer, with plans to begin operations in the middle or late part of the year.

When fully operational, the factory will have an annual production capacity of 500 MW of batteries and will employ at least 750 people.

President Tim Wiley says he is optimistic about the timeline for completion, as everything is currently on schedule.

"Some people can take seven months just to get a permit, and here we have the last beam going up seven months after the groundbreaking." For more information on the Form Energy facility, log on to www. FormEnergy.com. ■

er we've worked on with the House Speaker's office to create a pool of funding to cover tuition costs for our apprentices to receive associate degrees."

The two bills Capel referred to are HB 5200 and HB 5435.

HB 5200 would require public school guidance counselors to receive continuing education training on a number of issues, including trade apprenticeship programs, as a condition of employment.

"We believe HB 5200 will provide an opportunity for us to engage more meaningfully with the public school system to encourage young individuals to take on a career in the skilled trades," said Capel.

HB 5435 would create a new program, to be administered by the Council for Community and Technical College Education.

HB 5435 officially establishes the apprenticeship to associate of applied science degree program and creates a

pool of state funding that would cover the costs for WVBCT apprentices to receive associate degrees from local community colleges.

"We are calling this the Skilled Trades Apprenticeship Nontraditional Degree program or the 'STAND' program for short," said Capel. "We have worked with the House Speaker's office and the Council for Community and Technical Education to create this legislation, and we believe it would be a tremendous added benefit for our current members and a great incentive for future members to join our programs."

Capel says that if the legislation were to pass, the opportunity to receive associate degrees would be given to journey workers as well as current apprentices.
